More recently he was Partner at BDT Capital Partners (2002-2003) and was a Member of the Management Committee at the private equity group Investcorp (1995-2001). During this time Nick held Chairman and Non Executive Director roles at various Investcorp companies including Welcome Break (1997-2001) and Gucci (1995-1996). Nick began his career in finance, and is a chartered accountant.

Commenting on the appointment John Young, Chairman, said:

"I am delighted to welcome Nick to the Board as a Non-Executive Director. Nick brings enormous experience at Board level, coupled with immense industry knowledge. Over the years he has demonstrated strong commercial and financial acumen, through implementing a number of successful change programmes and demonstrating a genuine commitment to enhancing shareholder value. His skills and experience will be of great value to the Board as we continue to develop the Company and our strategic plans at this important juncture in Young's history."
